## GQA LEVEL 2 NVQ CERTIFICATE IN WALL AND FLOOR TILING (CONSTRUCTION)

### Who is this qualification for?

This is a work-based learning qualification that enables individuals to work as a tiler in the construction industry. It is not expected that all tilers carry out exactly the same tasks or work in the same environment, this is taken into account and the qualification can be assessed in both domestic, e.g. kitchens, bathrooms or in commercial sites such as shops, hotels, offices or restaurants.

### What is required from candidates?

The qualification requires individuals to prove competent to fix tiles to vertical, horizontal and inclined surfaces to given working instructions for both wall and floor surfaces, reveals, cills and soffits (door and/or windows), floor drainage and outlets and also in the fixture of appropriate accessories.

The main source of evidence for each unit will be observation of the candidate's performance and knowledge demonstrated during the completion of the unit. This can be supplemented by the following types of physical or documentary evidence:

- Accident book/reporting system
- Work diaries
- Correspondence with customers
- Training records
- Telephone log
- Photo/video evidence
- Witness testimonies
- Safety records
- Timesheets
- Notes and memos
- Audio evidence
- Materials

- Job specifications and documentation
- Work schedules and records

- Completed products/installations
